Attention of the Trade & Industry is invited to the procedure for reimbursement of Duty in lieu of drawback for supply of goods by DTA Units to SEZ Units/Developers prescribed vide Instruction No. 9 dated 18.02.2009 issued vide F.No. H 7/1/2007- SEZ by Government of India , Ministry of Commerce and Industry, Department of Commerce, (SEZ Division). Appropriate authority for sanction and disbursement of drawback claims on supplies made by DTA units to units or Developers in SEZ has been specified vide CBEC Circular No. 43/2007 Cus dated 05.12.2007 issued under F.No. 602/2/2002-DBK

- Subsequently vide Circular No. 39/2010 Customs dated 15:10.2010 issued under F. No. 602/02/2002-DBK 2. the procedure laid down in the Board Circular no. 43/2007 Cus dated 05.12.2007 has been modified to the extent that the Commissioners of Central Excise or Customs and Central Excise, as the case may be, may issue authorization to Dy/Asstt Commissioners of Central Excise posted in Divisions under them for the purpose of disbursing drawback to DTA Units against disclaimers issued by SEZ units/developers.
- 3. Accordingly Divisional Assistant/Deputy Commissioners of Central Excise of this Commissionerate has been authorized for disbursal of Drawback to such DTA units falling under their respective jurisdiction, against disclaimers issued by SEZ units/developers. Proposal involving Rs. 5 lakhs and above per claim shall be approved by the Joint/Additional Commissioner in Charge of Customs and Drawback, Raigad Commissionerate.
- The payment of Drawback to the claimant will be invariably made through RTGS/NEFT mode as is being done in case of disbursal of rebate claims.
- 5. All Trade Associations are requested to bring the contents of the above instructions to the notice of the trade in general and their member manufacturers in particular. This Notice is issued in the Public Interest.
